Four Paws Only requires proof of current Rabies, Distemper, and Bordetella vaccinations. Four Paws Only makes no guarantees regarding the Bordetella Vaccine.

All pets are checked for external parasites such as fleas and ticks upon entry to the facility. If any external parasites are found, they will be treated accordingly, and the owner will be responsible for expenses relating to treatment. If your pet becomes ill or his/her behavior is endangering themselves, humans, or other animals, we may engage the services of a veterinarian. All attempts will be made to contact the owner first, however, in the event of an emergency, the well-being of the pet comes first. Medication will be administered as directed by a veterinarian. The owner agrees to pay all costs and charges for special services requested in

addition to all veterinary expenses deemed appropriate by Four Paws Only for the pet during the time it is in Four Paws Only's care.
